BIS-SAHHA tas-setghet moghtija bl-artikoli 34, 35(8), 36 u 60 ta' l-Att dwar Kunsilli Lokali, il-Kunsill Lokali Fgura ghamel il-*Bye-Laws* li ġejjin:–

1.1 It-titolu ta' dawn il-*Bye-Laws* hu *Bye-Laws* ta' 1-2007 biex jemendaw il-*Bye-Laws* dwar Reklami fuq Ghamara tat-Toroq (Kunsill Lokali Fgura), u dawn ghandhom jinqraw u jiftiehmha waħda mal-*Bye-Laws* ta' 1-2005, dwar Reklami fuq Ghamara tat-Toroq (Kunsill Lokali Fgura) hawnhekk iżjed 'il quddiem imsejha il-*Bye-Laws* prinċipali.

1.2 Dawn il-*Bye-Laws* ghandhom jibdew isehhu xahar wara l-pubblikazzjoni tagħhom fil-Gazzetta.

2. Fl-artikolu 2 tal-*Bye-Laws* prinċipali, fit-tifsira “reklam”, minnufih wara l-kliem “kemm ta' xort' ohra” ghandhom jiżdiedu l-kliem “eskluzja kull promozzjoni politika”.

3. L-artikolu 3.2 tal-*Bye-Laws* prinċipali ghandu jiġi emendat kif ġejj:–

(a) minnufih wara l-kelma “iżda” fl-ewwel proviso ghandha tiżdied il-kelma “wkoll”; u

(b) minnufih qabel l-ewwel proviso ghandu jiżdied il-proviso ġdid li ġejj:

“Iżda dik l-awtorizzazzjoni ma tinghatax:

(a) għal kull reklam politiku;

(b) għal kull reklam f'siti fil-konfini tal-lokalità tal-Fgura hliet f'dawk is-siti elenkati fl-Ewwel Skeda li tinsab ma' dawn il-*Bye-Laws*; u

(ċ) fit-tieni proviso minflok il-kelma “wkoll” ghandha tidhol il-kelma “aktar”.

Jemenda l-artikolu 3.3 tal-*Bye-Laws* prinċipali.

4. Fit-tieni paragrafu ta’ l-artikolu 3.3 tal-*Bye-Laws* prinċipali minflok il-kelma “sena”, kull fejn tidher, ghandha tidhol il-kelma “sentejn”.

Jemenda l-artikolu 3.5 tal-*Bye-Laws* prinċipali.

5. Fl-artikolu 3.5 tal-*Bye-Laws* prinċipali minflok il-kliem “fl-Iskeda” ghandhom jidhlu l-kliem “fit-Tieni Skeda”.

Jemenda l-Iskeda li tinsab mal-*Bye-Laws* prinċipali.

6. Fl-Iskeda li tinsab ma’ dawn il-*Bye-Laws*, minnufih qabel il-kelma “SKEDA” ghandha tizzied il-kelma “IT-TIENI”.

Iżid l-Ewwel Skeda mal-*Bye-Laws* prinċipali.

7. Minnufih qabel it-Tieni Skeda li tinsab ma’ dawn il-*Bye-Laws*, kif enumerata, ghandha tizzied l-Iskeda ġdida li ġejja:

“L-EWWEL SKEDA

(Artikolu 3.2)

Siti fil-konfini tal-lokalità tal-Fgura li fihom l-awtorizzazzjoni ghar-reklamar fuq ghamara tat-toroq tista’ tinghata mill-Kunsill Lokali Fgura

Triq is-Sur
Triq Hompesch
Triq Haż-Żabbar
Triq San Tumas.”.

**LOCAL COUNCILS ACT
(CAP. 363)**

**Advertisements on Street Furniture
(Fgura Local Council) (Amendment) Bye-Laws 2007**

IN exercise of the powers conferred by articles 34, 35(8), 36 and 60 of the Local Councils Act, the Fgura Local Council has made the following Bye-Laws:-

1.1 The title of these Bye-Laws is Advertisement on Street Furniture (Fgura Local Council) (Amendment) Bye-Laws 2007 and shall be read and construed as one with the Advertisement on Street Furniture (Fgura Local Council) Bye-Laws, 2005, hereinafter referred to as “the principal Bye-laws.”.

Citation and commencement.
L.C.B.L. 17/5/2005.

1.2 These Bye-Laws shall come into force one month after their publication in the Gazette.

2. In article 2 of the principal Bye-Laws, in the definition “advertisement”, immediately after the words “or otherwise” there shall be added the words “excluding a political promotion”.

Amends article 2 of the principal Bye-Laws.

3. Article 3.2 of the principal Bye-Laws shall be amended as follows:

Amends article 3.2 of the principal Bye-Laws.

(a) immediately after the word “Provided”, in the first proviso, there shall be added the word “further”; and

(b) immediately before the first proviso there shall be added the following new proviso:

“Provided that such authorization shall not be granted:

(a) for any political advertisement;

(b) for any advertisement in sites within the Fgura locality boundary except in those sites enlisted in the First Schedule to these Bye-Laws; and

(c) for the word “further” in the second proviso there shall be substituted the word “also”.

Amends article 3.3
of the principal
Bye-Laws.

4. In the second paragraph of article 3.3 of the principal Bye-Laws for the words “one year”, wherever they appear, there shall be substituted the words “two years”.

Amends article 3.5
of the principal
Bye-Laws.

5. In article 3.5 of the principal Bye-Laws for the word “Schedule” there shall be substituted the words “Second Schedule”.

Amends the
Schedule to the
principal Bye-
Laws.

6. In the Schedule to these Bye-Laws, immediately before the word “SCHEDULE” there shall be added the word “SECOND”.

Adds First
Schedule to the
principal Bye-
Laws.

7. Immediately before the Second Schedule to these Bye-Laws, as renumbered, there shall be added the following new schedule:

“FIRST SCHEDULE

(Article 3.2)

Sites within the Fgura locality boundary wherein authorization to advertise on street furniture may be granted by the Fgura Local Council

Bastion Street
Hompesch Road
Żabbar Road
St. Thomas Street.”.
