***Bye-Laws* tal-2009 li jirregolaw il-Karozzini ġewwa l-Imdina
(Kunsill Lokali Imdina)**

BIS-SAHHA tas-setgħat mogħtija bl-artikoli 34 u 35(8) ta' l-Att dwar Kunsilli Lokali, il-Kunsill Lokali Imdina għamel il-*Bye-Laws* li ġejjin:-

1. It-titolu ta' dawn il-*Bye-Laws* hu "*Bye-Laws* ta' l-2009 li jirregolaw il-Karozzini ġewwa l-Imdina". Titolu.

1.2 Dawn il-*Bye-Laws* jidhlu fis-seħħ mal-pubblikazzjoni tagħhom fil-Gazetta. Bidu fis-seħħ.

2. F'dawn il-*Bye-Laws*, kemm-il darba r-rabta tal-kliem ma teħtieġx xort'oħra:- Tifsir.

“l-Att” tfisser l-Att dwar il-Kunsilli Lokali;

“il-Kunsill” tfisser il-Kunsill Lokali tal-Imdina;

“karozzin” tfisser karozzin u kull vettura miġbuda minn animal;

“lokalità” tfisser il-lokalità tal-Imdina kif murija fl-Ewwel Skeda li tinsab mal-Att.

3. Kull karozzin użata b'kiri jew b'kumpens tista' tiċċirkola fl-Imdina f'kull hin sakemm il-qawqab tal-annimal u r-roti tal-karozzin ikunu miksjja bil-lastku: Cirkolazzjoni tal-karozzini u l-użu tal-lastku fuq il-qawqab u r-roti tal-karozzin.

Izda l-Kunsill jista' joħroġ permess biex karozzin li ma jkollux ir-roti miksjja bil-lastku jkun jista' jidhol fl-Imdina f'xi okkażjoni speċjali.

4. Persuna li tinsab haġja bi ksur ta' dawn ir-regolamenti tista' meta tinsab haġja teħel ammenda ta' sittin euro. Piena.

**LOCAL COUNCILS ACT
(CAP. 363)**

**Use of Animal-drawn Carriages (Mdina Local Council)
Bye-Laws, 2009**

IN exercise of the powers conferred by articles 34 and 35(8) of the Local Councils Act, the Mdina Local Council has made the following Bye-Laws:-

- Citation. **1.** The title of these Bye-Laws may be cited as Use of Animal-drawn Carriages (Mdina Local Council) Bye-Laws, 2009.”
- Commencement. **1.2** These Bye-Laws shall come into force upon their publication in the Gazette.
- Interpretation. **2.** In these Bye-Laws, unless the context otherwise requires:-
- “Animal-drawn carriage” means a karozzin and any animal-drawn vehicle;
- “the Act” means the Local Councils Act;
- “the Council” means the Mdina Local Council;
- “locality” means the Mdina locality as shown in the First Schedule to the Act.
- Circulation of horse-drawn carriages and the use of rubber covers on hooves and carriage wheels. **3.** Horse-drawn carriages used for hire or in compensation may circulate within Mdina at all times provided the animal’s hooves and the carriage wheels are fitted with rubber covers:
- Provided that the Mdina Local Council may issue a permit for an animal-drawn carriage not fitted with rubber covered wheels to access Mdina on a special occasion.
- Penalties. **4.** Any person who is found guilty of contravening these regulations shall, on conviction, be liable to a fine (*ammenda*) of sixty euro.
