## Posts of Registrar in the Department of Surgery in the Health Division

2. Il-post ta' Registratur għandu salarju ta' Lm6,688 fis-sena li jiżdied b'Lm256 fis-sena sa massimu ta' Lm8,224.

2. The post of Registrar carries a salary of Lm6,688 per annum rising by annual increments of Lm256 up to a maximum of Lm8,224.
