In exercise of the powers vested in him by Article 92(4) of the Constitution of Malta, the Prime Minister and Minister of Finance, after consultation with the Public Service Commission, has appointed Dr Kenneth Grech, M.D., M.Sc.(Lond), M.B.A., D.L.S.H.T.M., as Director (*Social Welfare Standards*) within the Ministry for the Family and Social Solidarity with effect from 17th October, 2006.

Avviż lill-Baħħara Nru. 57 ta' l-2006**Notice to Mariners No. 57 of 2006***Image Projectors fuq il-Forti Sant' Anġlu**Image Projectors against Fort St Angelo*

L-Awtorità ta' Malta dwar it-Turizmu se torganizza żewġ avvenimenti fil-Ġonna tal-Barrakka ta' Fuq fil-Belt Valletta fit-2 u l-5 ta' Diċembru, 2006. Parti mill-avvenimenti jinkludu loġhob tan-nar mix-xatt tal-ponta ta' Bighi u *image projections* fuq il-Forti Sant' Anġlu.

The Malta Tourism Authority will be hosting two events at the Upper Barrakka Gardens in Valletta on 2nd and 5th December, 2006. Part of the events include a fireworks display from Bighi point shore and image projections against Fort St Angelo.

Minhabba dan ta' hawn fuq, ngħarrfu 'l-baħħara illi parti mill-Port il-Kbir se tkun magħluqa għall-bastimenti u inġenji kollha bejn id-9.00 p.m. u l-10.30 p.m. hin lokali (8.00 p.m. u 9.30 p.m. UTC) fid-dati tal-wirjiet imsemmija hawn fuq.

In view of the above, mariners are informed that part of the Grand Harbour will be closed to all vessels and craft between 2100 hours and 2230 hours local time (2000 hours and 2130 hours UTC) on the above-mentioned dates of the displays.

Linja immaginarja tghaqqad l-area ristretta mill-ponot li ġejjin:

An imaginary line binds the restricted area from the following points:

1. Fuq it-Tramuntana tal-Ponta ta' Sant' Anġlu għall-*Breakwater* tar-Rikasoli u l-kosta bejniethom u mill-Ponta ta' Sant' Anġlu sa Xatt il-Barriera.

1 On the North from St Angelo Point to Ricasoli Breakwater and the intermediate coastline and from St Angelo Point to Barriera Wharf.

2. Fuq in-Nofsinhar mix-Xatt ta' Sant' Anġlu għat-tarf tan-Nofsinhar tax-Xatt ta' Lascaris.

2 On the South from St Angelo's Wharf to south end of Lascaris Wharf.

M'għandhomx jithallew inġenji rmunkati 'l hinn mix-xatt bejn il-ponta ta' Bighi u l-ponta ta' l-Isptar.

No craft is to be left moored off the shore between Bighi point and Hospital point.

L-ebda bastiment ma jithalla jidhol fl-area ristretta, kemm il darba ma jkollux permess speċjali minghand id-Direttur Eżekuttiv (Portijiet). Il-baħħara għandhom jobdu l-ordnijiet mogħtija mis-Signal Station tat-Torri tal-Palazz (PTSS).

No vessel will be allowed to enter the restricted area, except by special permission from the Executive Director (Ports). Mariners are to abide with instructions given by Palace Tower Signal Station (PTSS).
