**LOCAL COUNCILS ACT
(CAP. 363)**

**Local Councils (Delegation of Street Lighting Installations)
(Amendment) (No. 2) Order, 2003**

IN exercise of the powers conferred by article 33(1) and by article 72 of the Local Councils Act, hereinafter referred to as “the Act”, the Minister for Justice and Local Government has made the following order:–

Title. **1.** The title of this order is the Local Councils (Delegation of Street Lighting Installations) (Amendment) (No. 2) Order, 2003, and shall be read and construed as one with the Local Councils (Delegation of Street Lighting Installations) Order, 2002, hereinafter referred to as “the principal order”.

L.N. 114 of 2002.

Amends the Second Schedule to the principal order.

2. In the Second Schedule to the principal order for the words from “Attard” to “Żabbar” under the heading “Local Council”, and for the words “To be established” under the heading “Effective date of delegation” there shall be substituted the following:–
