Dwar Kunsilli Lokali (Finanzi)**

BIS-SAHHA tas-setghat moghtija bl-artikoli 67 u 72 ta' l-Att dwar Kunsilli Lokali, il-Ministru tal-Ġustizzja u l-Intern, flimkien mal-Ministru tal-Finanzi u l-Affarijiet Ekonomiċi ghamel ir-Regolamenti li ġejjin:—

1. It-titolu ta' dawn ir-regolamenti hu Regolamenti ta' l-2003 li jemendaw ir-Regolamenti dwar Kunsilli Lokali (Finanzi), u ghandhom jinqraw u jinftehm u haġa wahda mar-Regolamenti ta' l-1993 dwar Kunsilli Lokali (Finanzi), hawnhekk iżjed 'il quddiem imsejja "ir-regolamenti prinċipali".

Titolu.

2. Is-subregolament (1) tar-regolament 4 tar-regolamenti prinċipali ghandu jiġi emendat kif ġejj:—

Jemenda r-regolament 4 tar-regolamenti prinċipali.

(a) fir-regolament (ċ) tiegħu minflok il-kliem "fl-Att;" ghandhom jidhlu l-kliem "fl-Att:"; u

(b) minnufih fit-tmiem il-paragrafu (ċ) ghandu jiżdied dan il-proviso li ġejj:—

"Izda mill-1 ta' Ottubru, 2003 sal-31 ta' Marzu, 2004, ghandha tapplika rata ta' mhux anqas minn hamsa fil-mija ta' l-allokkazzjoni approvata skond l-Att minflok ir-rata ta' ghaxra fil-mija imsemmija hawn aktar qabel ghal perijodi ohra.".

**LOCAL COUNCILS ACT
(CAP. 363)**

Local Councils (Financial) (Amendment) Regulations, 2003

IN exercise of the powers conferred by articles 67 and 72 of the Local Councils Act, the Minister for Justice and Home Affairs, in conjunction with the Minister of Finance and Economic Affairs, has made the following regulations:—

Title.

1. The title of these regulations is the Local Councils (Financial) (Amendment) Regulations, 2003 and they shall be read and construed as one with the Local Councils (Financial) Regulations 1993, hereinafter referred to as “the principal regulations”.

Amends regulation 4 of the principal regulations.

2. Subregulation (1) of regulation 4 of the principal regulations shall be amended as follows:—

(a) in regulation (c) thereof, for the words “in the Act;” there shall be substituted the words “in the Act.”; and

(b) immediately at the end of paragraph (c) there shall be added the following proviso:—

“Provided that as from 1 October, 2003 to 31 March, 2004, there shall apply a rate of not less than five per cent of the allocation approved in terms of the Act instead of the aforementioned rate of ten per cent applicable for other periods.”.
