**Regolamenti ta' l-2004 dwar Drittijiet għal Servizzi
mill-Ispettorat tas-Sahha**

BIS-SAHHA tas-setghat mogħtija bl-artikolu 2 ta' l-Ordinanza dwar id-Drittijiet, il-Ministru tas-Sahha, bi ftehim mal-Ministru tal-Finanzi u l-Affarijiet Ekonomiċi, għamel dawn ir-regolamenti li ġejjin:–

1. Superviżjoni, kemm mitluba kemm mhix, waqt il-qerda ta' oġġetti ta' l-ikel. Lm10 għall-ewwel 10 kg u Lm5 għal kull 10 kg addizzjonali jew parti minnhom, sa l-oghla ammont ta' Lm200.
2. Tehid ta' kampjuni u analiżi ta' ilma tal-bir, minbarra dawk il-kampjuni li s-Suprintendent iqis bhala li huma bżonnjużi li jittiehdu bil-ghan ta' xi investigazzjoni. Lm15 kull kampjun.
3. Hruġ ta' Ċertifikat tas-Sahha għall-Esportazzjoni mill-uffiċċju msemmi mis-Suprintendent bhala li għandu johroġ dak iċ-ċertifikat. Lm25 kull ċertifikat.
4. Żjarat f'postijiet ta' l-ikel jew postijiet ta' l-ikel proposti għal skop ta' konsultazzjoni dwar il-liġijiet fuq l-iġjene ta' l-ikel f'postijiet ta' l-ikel, barra minn dawk il-konsultazzjonijiet skond il-paragrafu 5 ta' din l-Iskeda u parir mogħti konformement ma' spezzjoni magħmula skond l-Att dwar is-Sigurtà fl-Ikel. Lm10 kull żjara f'dawk il-postijiet ta' l-ikel.

6. Hruġ ta' ċertifikat ta' registrazzjoni ta' post ta' l-ikel skond ir-Regolamenti ta' l-2001 dwar ir-Registrazzjoni ta' Postijiet ta' l-Ikel (A.L. 180 ta' l-2001), meta dan iċ-ċertifikat ikun hekk mitlub. Lm5 kull ċertifikat.

**FEES ORDINANCE
(CAP. 35)**

Health Inspectorate Services (Fees) Regulations, 2004

IN exercise of the powers conferred by article 2 of the Fees Ordinance, the Minister of Health, with the concurrence of the Minister of Finance and Economic Affairs, has made the following regulations:—

1. The title of these regulations is the Health Inspectorate Services (Fees) Regulations, 2004. Citation.

2. In these regulations, unless the context otherwise requires — Interpretation.

“Superintendent” means the Superintendent of Public Health;

“food” shall have the same meaning as is assigned to it in the Food Safety Act. Cap. 449.

3. (1) The fees specified in the Schedule to these regulations shall be levied by the Superintendent of Public Health for the services listed therein. Fees due.

(2) Notwithstanding the provisions of sub-regulation (1) hereof, the Superintendent may at any time refuse to offer any service listed in the said Schedule.

(3) The fees prescribed in the Schedule hereto are without prejudice to any other fees that may be due for any other services rendered by the Health Inspectorate.

SCHEDULE

(Regulation 3)

Service	Fee
1. Supervision, whether requested or not, during the destruction of foodstuffs.	Lm10 for the first 10 kg and Lm5 for each additional 10 kg or part thereof, up to a maximum of Lm200.
2. Sampling and analysis of well water, excluding samples that the Superintendent deems as required to be taken for the purpose of an investigation.	Lm15 per sample.
3. Issuing of an Export Health Certificate by the office designated by the Superintendent to issue such certificate.	Lm25 per certificate.
4. Visits to a food premises or proposed food premises for the purpose of consultation on the legal requirements with respect to food hygiene in the food premises, excluding those consultations in terms of paragraph 5 hereof and any advice given pursuant to an inspection performed in terms of the Food Safety Act.	Lm10 per visit to such food premises.
<p>Provided that a written report of such consultation is to be given whenever so requested.</p>	
5. Visits to a food premises or proposed food premises for the purpose of consultation on the legal requirements with respect to food hygiene whereby such consultation is given in terms of a trading licence or a MEPA application.	Lm10 per visit to such food premises following the second visit.
6. Issuing of a food premises registration certificate in terms of the Food Premises (Registration) Regulations, 2001 (L.N. 180 of 2001), whenever such certificate is so required.	Lm5 per certificate.
