**1.** (1) It-titolu ta' dan l-ordni hu Ordni ta' l-2004 li jemenda l-Ordni dwar id-Delega ta' Infurzar mill-Kunsilli Lokali (Emenda Nru. 2), u l-Ordni ghandu jinqara u jiftiehem haġa wahda ma' l-Ordni ta' l-2000 dwar id-Delega ta' Infurzar mill-Kunsilli Lokali, hawnhekk iżjed 'il quddiem imsejjah "l-ordni prinċipali".

Titolu u bidu fis-sehh.

A.L. 32 ta' l-2000.

(2) Dan l-ordni ghandu jitqies li daħal fis-sehh fil-11 ta' Marzu, 2004.

**2.** It-Tieni Skeda li tinsab ma' l-ordni prinċipali ghandha tiġi emendata kif ġej:-

Jemenda t-Tieni Skeda li tinsab ma' l-ordni prinċipali.

(a) fit-Taqsima I tagħha minnufih wara l-kliem "Mdina," fl-ewwel kolonna intitolata "Kunsill Lokali" ghandhom jidhlu l-kliem "Mtarfa," u minnufih wara l-kliem "Dingli b'effett mill-ġdid mill-1 ta' Novembru, 2002" fit-tieni kolonna intitolata "Data tad-Delega effettiva" ghandhom jidhlu l-kliem "Mtarfa b'effett mill-ġdid mill-11 ta' Marzu, 2004"; u

(b) it-Taqsima II tagħha ghandha tithassar.

**LOCAL COUNCILS ACT  
(CAP. 363)**

**Local Councils (Delegation of Enforcement) (Amendment)  
(No. 2) Order, 2004**

IN exercise of the powers conferred by articles 33(1), 36(6) and 72 of the Local Councils Act, the Deputy Prime Minister and Minister for Justice and Home Affairs has made the following order:–

Citation and commencement.

L.N. 32 of 2000.

**1.** (1) The title of this order is the Local Councils (Delegation of Enforcement) (Amendment) (No. 2) Order, 2004 and it shall be read and construed as one with the Local Councils (Delegation of Enforcement) Order, 2000, hereinafter referred to as “the principal order”.

(2) This Order shall be deemed to have come into force on the 11th March, 2004.

Amends the Second Schedule to the principal order.

**2.** The Second Schedule to the principal order shall be amended as follows:–

(a) in Part I thereof immediately after the words “Mdina,” under column “Local Councils” there shall be added the word “Mtarfa,” and immediately after the words “Dingli again with effect from 1st November, 2002” under column “Effective date of delegation” there shall be added the words “Mtarfa again with effect from 11th March, 2004”; and

(b) Part II thereof shall be deleted.
