**Regolamenti ta' l-2004 li jemendaw ir-Regolamenti dwar  
l-Iġjene ta' l-Ikel (Emenda Nru.2)**

BIS-SAHHA tas-setghat moghtija bl-artiklu 10 ta' l-Att dwar is-Sigurtà fl-Ikel, il-Ministru tas-Sahha, l-Anzjani u Kura fil-Komunità ghamel dawn ir-regolamenti li ġejjin:

**1.** It-titolu ta' dawn ir-regolamenti hu Regolamenti ta' l-2004 li jemendaw ir-Regolamenti dwar l-Iġjene ta' l-Ikel (Emenda Nru. 2), u ghandhom jinqraw u jiftiehm bhalha haġa wahda mar-Regolamenti ta' l-2002 dwar l-Iġjene ta' l-ikel, hawn aktar 'il quddiem imsejhin "ir-regolamenti prinċipali".

Titolu.

**2.** Minflok ir-regolament 8 tar-regolamenti prinċipali ghandu jiġi mhassar u floku jidhol dan li ġej:

Jemenda r-regolament 8 tar-regolamenti prinċipali.

"8. (1) Bla preġudizzju ghal paragrafu 8.2 hawn taht, il-proprjetarju ta' negozju fl-ikel ghandu jhares id-disposizzjonijiet stipulati fl-Iskeda li tinsab ma' dawn ir-regolamenti.

(2) Il-proprjetarju ta' negozju fl-ikel jista' jidderoga mill harsien tad-disposizzjonijiet dwar l-iġjene kif stipulati fl-Iskeda li tinsab ma' dawn ir-regolamenti sakemm dak il-proprjetarju d-disposizzjonijiet tad-Direttiva tal-Kummissjoni 96/3/EC kif emendata bid-Direttiva tal-Kummissjoni 2004/4/EC (verżjoni kif korretta) jew skond id-Direttiva tal-Kummissjoni 98/28/EC."

**FOOD SAFETY ACT  
(CAP. 449)**

**Hygiene of Food (Amendment) (No.2) Regulations, 2004**

IN exercise of the powers conferred by article 10 of the Food Safety Act, the Minister of Health, the Elderly and Community Care has made the following regulations:–

Citation.

**1.** The title of these regulations is the Hygiene of Food (Amendment) (No.2) Regulations, 2004, and they shall be read and construed as one with the Hygiene of Foods Regulations, 2002, hereinafter referred to as “the principal regulations”.

Amends regulation 8 of the principal regulations.

**2.** For regulation 8 of the principal regulations, there shall be substituted the following:–

“8. (1) Subject to subregulation (2) hereof, the proprietor of a food business shall comply with the provisions set out in the Schedule to these regulations.”

(2) The proprietor of a food business may derogate from compliance with the provisions of hygiene as set in the Schedule to have regulations provided that such proprietor does so in accordance with Commission Directive 96/3/EC as amended by Commission Directive 2004/4/EC (corrected version) or in accordance with Commission Directive 98/28/EC.”.
