

A.L. 1 ta' l-2007**ATT DWAR IL-KARTI TA' L-IDENTITÀ
(KAP. 258)****Regolamenti ta' l-2007 li jemendaw ir-Regolamenti dwar il-Hruġ
u Validità ta' Karti ta' l-Identità**

BIS-SAHHA tas-setgħat mogħtija bl-artikolu 13 ta' l-Att dwar il-Karti ta' l-Identità, il-Prim Ministru għamel dawn ir-regolamenti li ġejjin:—

1. Dawn ir-regolamenti jistgħu jissejju r-Regolamenti ta' l-2007 li jemendaw ir-Regolamenti dwar il-Hruġ u Validità ta' Karti ta' l-Identità, u għandhom jinqraw u jiftehmu haġa waħda mar-Regolamenti ta' l-1996 dwar il-Hruġ u Validità ta' Karti ta' l-Identità, hawnhekk iżjed 'il quddiem imsejha "ir-regolamenti prinċipali".

Titolu.

2. Il-‘proviso’ li hemm fil-paragrafu (1) tar-regolament 3 tar-regolamenti prinċipali għandu jiġi sostitwit b’dan li ġej:—

Jemenda r-regolament 3 tar-regolamenti prinċipali.

“Izda, b’senh mill-1 ta’ Jannar, 2007, kull karta ta’ l-identità mahruġa wara l-15 ta’ Jannar, 2002 u qabel l-1 ta’ Jannar, 2006 li tiskadi qabel il-31 ta’ Diċembru 2007 għandha, minkejja d-data ta’ l-iskadenza murija fuq il-karta ta’ l-identità bħal dik, tibqa’ hekk valida sal-31 ta’ Diċembru, 2007 u dik il-karta ta’ l-identità ma għandhiex titqies li tkun skadiet qabel il-31 ta’ Diċembru, 2007.”.

3. Ir-Regolamenti ta’ l-2006 li jemendaw ir-Regolamenti dwar il-Hruġ u Validità ta’ Karti ta’ l-Identità huma b’dan imħassrin.

**IDENTITY CARD ACT
(CAP. 258)**

**Identity Cards (Issue and Validity) (Amendment) Regulations,
2007**

IN exercise of the powers conferred by article 13 of the Identity Card Act, the Prime Minister has made the following regulations:–

Citation.

1. These regulations may be cited as the Identity Cards (Issue and Validity) (Amendment) Regulations, 2005 and shall be read and construed as one with the Identity Cards (Issue and Validity) Regulations, 1996 hereinafter referred to as “the principal regulations”.

L.N. 47 of 1996.

Amends regulation 3 of the principal regulations.

2. The proviso in paragraph (1) of regulation 3 of the principal regulations shall be substituted with the following:–

“Provided that, with effect from the 1st of January, 2007, any identity card issued after the 15th of January, 2002 and prior to the 1st of January, 2006 which expires before the 31st of December, 2007 shall, notwithstanding the expiry date appearing on such identity card, remain valid up to the 31st December, 2007 and such identity card shall not be deemed to have expired before the 31st December 2007.”.

Revokes L.N. 9 of 2006.

3. The Identity Cards (Issue and Validity) (Amendment) Regulations, 2006 are hereby repealed.
