**L.N. 83 of 2007****FEES ORDINANCE  
(CAP. 35)****Fees for Maps (Department for Local Government)  
Regulations, 2007**

IN exercise of the powers conferred by article 2 of the Fees Ordinance, the Deputy Prime Minister and Minister for Justice and Home Affairs, with the concurrence of the Prime Minister and Minister of Finance has made the following regulations:-

Citation. **1.** The title of these regulations is Fees for Maps (Department for Local Government) Regulations, 2007.

Fees payable. **2.** There shall be charged by the Department for Local Government in respect of each map of AO or A1 size issued by the said Department a fee as follows:-
