**Delegation of Administration of Facilities to
Mosta Local Council Order, 2007**

IN exercise of the powers conferred by articles 33(1)(m) and 72 of the Local Councils Act, the Deputy Prime Minister and Minister for Justice and Home Affairs, has made the following order:–

Citation.

1. The title of this order is the Delegation of Facilities Mosta Local Council Order, 2007.

Delegation of functions.

2. The property described in article 3 of this Order is hereby being specified for the purposes of the delegation of functions mentioned in paragraph (m) of subarticle (1) of article 33 of the Local Councils Act, as from the date of the publication of this order.

Description.

3. The property in the locality of Mosta referred to in article 2 of the order consists of underground shelter at Pjazza Rotunda, Mosta as shown bordered on plan P.D. 2007_9 attached to the Lease Agreement for the Administration and Use of the underground shelter in Pjazza Rotunda Mosta, by Mosta Local Council, signed by the Director Land on behalf of the Government of Malta and the Mayor and Executive Secretary of the Mosta Local Council on the 27th February, 2007.
