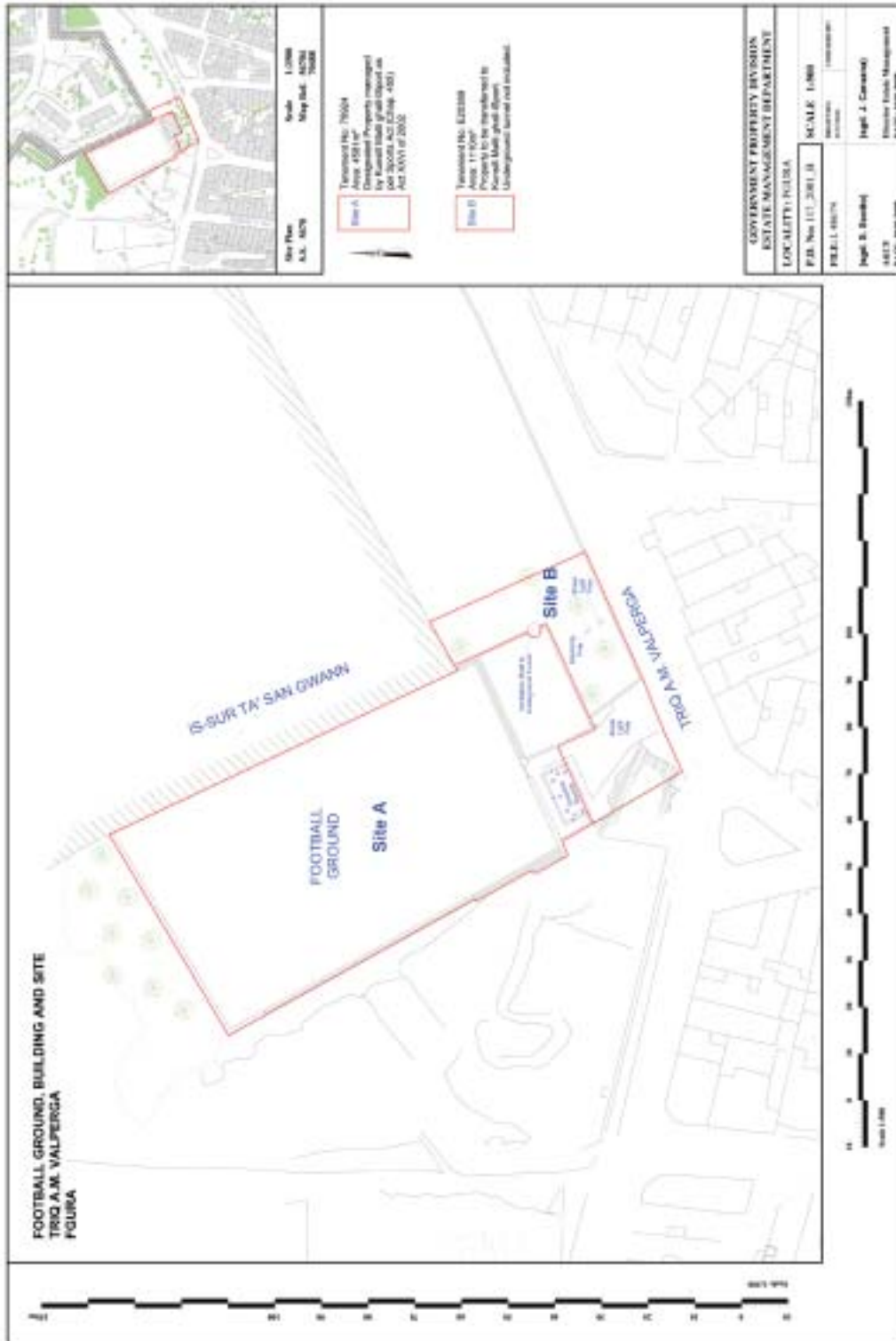

**Kunsill Malti għall-*I sport* (Transfer of Designated Property)
Order, 2008**

IN exercise of the powers conferred by article 16 of the Sports Act, the President of Malta has made the following order:–

1. The title of this order is the Kunsill Malti għall-*I sport* Citation.
(Transfer of Designated Property) Order, 2008.
2. The property described in article 4 of this order is hereby Designated property.
being designated for the purpose of the enjoyment, possession, use and management of all rights and obligations performing to such designated property in terms of article 16 of the Sports Act.
3. The designated property referred to in article 2 of this order Appointed day.
shall be transferred and vest in the Kunsill Malti għall-*I sport* as provided in the aforesaid article with effect from the 1st January 2008.
4. The property referred to in article 2 of this order is the Description of designated property.
following, that is to say:

A plot of land in Triq A. M. Valperga, Fgura, having an area of approximately 1,110 square metres, bounded on all sides by Government property, excluding underground tunnel, as indicated edged red on P.D. 117_2001_B.
