**ENEMALTA ACT  
(CAP. 272)**

**Electricity Supply (Amendment) Regulations, 2008**

IN exercise of the powers conferred by articles 20 and 39 of the Enemalta Act, Enemalta, with the approval of the Minister for Infrastructure, Transport and Communications, and with the approval of the Malta Resources Authority: -

Citation and commencement.

G.N. 223 of 1940.

**1.** (1) The title of these regulations is the Electricity Supply (Amendment) Regulations, 2008 and they shall be read and construed as one with the Electricity Supply Regulations, 1939 hereinafter referred to as “the principal regulations”.

(2) These regulations shall be deemed to have come into effect on the 1st July, 2008.

Amends the First Schedule to the principal regulations.

**2.** In item (vi) of the First Schedule to the principal regulations for the words “50%”, there shall be substituted the words “95%”.

Amends the Second Schedule to the principal regulations.

**3.** In Item (3) of the Second Schedule to the principal regulations for the words “50%”, there shall be substituted the words “95%”.

Amends the Third Schedule to the principal regulations.

**4.** In Item 5 of the Third Schedule to the principal regulations for the words “50%”, there shall be substituted the words “95%”.
