**MEDICINES ACT
(CAP. 458)**

**Manufacture and Importation of Medicinal Products
for Human Use (Amendment) Regulations, 2009**

IN exercise of the powers conferred by article 106 of the Medicines Act, the Minister for Social Policy has made the following regulations:-

Title.

1. The title of these regulations is the Manufacture and Importation of Medicinal Products for Human Use (Amendment) Regulations, 2009 and they shall be read and construed as one with the Manufacture and Importation of Medicinal Products for Human Use Regulations, 2005 hereinafter referred to as “the principal regulations”.

2. In regulation 3 of the principal regulations, in paragraph (b) of sub-regulation (2) thereof, for the words “retail supply, by pharmacists” there shall be substituted the words “retail supply by pharmacists”.

3. In the Maltese text of regulation 9 of the principal regulations, in paragraph (b) thereof, for the words “ta’ l-anqas wieħed minn dawn is-sugġetti” there shall be substituted the words “ta’ l-anqas dawn is-sugġetti”.
