

L.N. 119 of 2010**PLANT QUARANTINE ACT
(CAP. 433)****Plant Quarantine (Harmful Organisms) (Amendment) (No. 2)
Regulations, 2010**

IN exercise of the powers conferred by article 32 of the Plant Quarantine Act, the Minister for Resources and Rural Affairs has made the following regulations.

1. (1) The title of these regulations is the Plant Quarantine (Harmful Organisms) (Amendment) (No. 2) Regulations, 2010 and they shall be read and construed as one with the Plant Quarantine (Harmful Organisms) Regulations, 2004, hereinafter referred to as “the principal regulations”.

Title and scope.

(2) The scope of these regulations is to transpose Commission Directive 2010/1/EU of 8 January, 2010 amending Directive 2000/29/EC.

2. In Part B of Schedule II to the principal regulations, in point 2 of heading (b) Bacteria, for the text in the third column, Protected zone(s), there shall be substituted the following:

Amends Schedule II to the principal regulations.

Amends Schedule III to the principal regulations.

3. Part B of Schedule III to the principal regulations shall be amended as follows:

(a) in point 1, for the text in the second column, Protected zone(s), there shall be substituted the following:

(b) in point 2, for the text in the second column, Protected zone(s), there shall be substituted the following:

SK (except the communes of Blahová, Horné Mýto and Okoč (Dunajská Streda County), Hronovce and Hronské Kláčany (Levice County), Málíneec (Poltár County), Hrhov (Rožňava County), Veľké Ripňany (Topoľčany County), Kazimír, Luhyňa, Malý Horeš, Svätušie and Zátín (Trebišov County)), FI, UK (Northern Ireland, Isle of Man and Channel Islands)”.

4. Part B of Schedule IV to the principal regulations shall be amended as follows:

Amends Schedule IV to the principal regulations.

(a) point 21 shall be amended as follows:

(i) in the second column, Special requirements, for point (c) there shall be substituted the following:

“(c) the plants originate in the Canton of Valais in Switzerland, or”;

(ii) for the text in the third column, Protected zone(s), there shall be substituted the following:
