**ORDINANZA DWAR IR-REGOLAMENT  
TAT-TRAFFIKU  
(KAP. 65)****Regolamenti ta' l-2004 dwar Restrizzjoni ta' Dhul u Passaġġ  
ta' Vetturi fl-Mdina**

BIS-SAHHA tas-setghat moghtija bl-artikolu 54(2)(g) ta' l-Ordinanza dwar ir-Regolament tat-Traffiku, il-Ministru għall-Iżvilupp Urban u Toroq, wara konsultazzjoni ma' l-Awtorità dwar it-Trasport ta' Malta, bi ftehim mal-Viċi Prim Ministru u Ministru tal-Ġustizzja u l-Intern, għamel dawn ir-regolamenti li ġejjin:-

1. It-titolu ta' dawn ir-regolament hu Regolament ta' l-2004 dwar Restrizzjoni ta' Dhul u Passaġġ ta' Vetturi fl-Mdina. Titolu.
2. Ebda vettura, hliet karrozzin, ma tista' tidhol f'xi triq jew pjazza fl-Mdina u lanqas tiċċirkola f'dik il-belt f'ebda hin. Vetturi li ma jistgħux jidhlu.
3. Minkejja d-disposizzjonijiet tar-regolament 2:- Eċċezzjonijiet.
  - (a) vetturi li jkollhom liċenza f'isem residenti ta' l-Mdina, vetturi tat-tiġijiet, ambulanzi, vetturi tat-tifi tan-nar u vetturi tal-pulizija, vetturi tal-mejtin u vettura waħda tal-funeral, u vetturi użati minn tobba msejhin biex jinvistaw persuni fl-Mdina, għandu jkollhom kull dritt ta' dhul u passaġġ hemmhekk f'kull hin;
  - (b) vetturi kummerċjali li jikkunsinnaw jew ibiegħu oġġetti fl-Mdina jkunu jistgħu jiċċirkolaw fl-Mdina għal dawg l-għaniyet, bejn is-6.00 u l-10.30 ta' fil-ghodu u bejn it-3.30 u l-5.00 ta' wara nofsinhar fil-ġranet kollha;
  - (ċ) *mini-buses*, mikrijin biex iwasslu tfal li jattendu skejjel fl-Mdina, jistgħu jiċċirkolaw fl-Mdina bejn is-7.30 u d-9.00 ta' fil-ghodu u bejn is-1.00 u s-2.00 ta' wara nofsinhar fil-ġranet ta' l-iskola;
  - (d) *taxi-cars*, u karrozzi mikrija bix-xufier, ikollhom biss aċċess u passaġġ fl-Mdina, minghajr parkeġġ, biex iwasslu residenti minn u lejn lukandi u residenzi fl-Mdina.

Il-Kunsill Lokali Mдина jista' jaghti permessi ghal dhul temporanju.

**4.** (1) Il-Kunsill Lokali Mдина jista' jaghti permess biex vetturi jidhlu u jiċċirkolaw fil-belt ta' l-Mдина ghal xi ghan jew raġuni speċifika b'dawk il-kondizzjonijiet li l-Kunsill Lokali Mдина jista' jidhirlu xieraq li jimponi.

Formola biex issir applikazzjoni.

(2) L-applikazzjoni għall-permess imsemmi fis-subregolament (1) ta' dan ir-regolament għandha ssir bil-miktub fuq il-formola apposta li hemm fl-Iskeda li tinsab ma' dan l-ordni, u dik l-applikazzjoni għandha tiġi pprocessata mill-Kunsill Lokali Mдина wara li jsir hlas amministrattiv ta' Lm1 lill-Kunsill Lokali Mдина ghal kull applikazzjoni.

Il-permess jiġi ffirmit mis-Sindku u s-Segretarju Eżekuttiv.

(3) Dak il-permess għandu jkun bil-miktub u jiġi ffirmit mis-Sindku u s-Segretarju Eżekuttiv tal-Kunsill Lokali Mдина, u għandu jintwera fil-vettura b'tali mod li dan ikun jista' jidher u jinqara minn barra l-vettura f'kull hin li l-vettura tkun fl-Mдина.

Il-permess ma jaqbiżx 12-il xahar u mhuwiex trasferibbli.

(4) Dak il-permess għandu jinhareġ ghal perjodu li ma jkunx aktar minn 12-il xahar mid-data tal-hruġ tiegħu u dan la jkun trasferibbli ghal xi persuna ohra u lanqas ghal xi vettura ohra.

**TRAFFIC REGULATION ORDINANCE  
(CAP. 65)**

**Mdina (Restriction of Access and Transit of Vehicles)  
Regulation, 2004**

IN EXERCISE of the powers conferred by article 54(2)(g) of the Traffic Regulation Ordinance, the Minister for Urban Development and Roads, in consultation with the Malta Transport Authority, and in concurrence with the Deputy Prime Minister and Minister for Justice and Home Affairs, has made the following regulations:-

- Title.                   **1.** The title of these regulations is the Mdina (Restriction of Access and Transit of Vehicles) Order, 2004.
- Vehicles prohibited access.                   **2.** No vehicle, other than *karrozzin*, shall have access to any street or square inside Mdina nor circulate within that city at any time.
- Exceptions.                   **3.** Notwithstanding the provisions of regulation 2 –
- (a) vehicles licensed in the name of residents of Mdina, bridal cars, ambulances, fire-fighting and police vehicles, hearses and one funeral car, and vehicles being used by doctors on call on a person within Mdina, shall have complete access and transit therein at all times;
- (b) commercial vehicles delivering or selling goods within Mdina may circulate within Mdina for such purposes between 6.00a.m. and 10.30a.m. and between 3.30p.m. and 5.00p.m. on all days;
- (c) mini-buses, hired for the conveyance of children attending schools within Mdina, may circulate within Mdina between 7.30a.m. and 9.00a.m. and between 1.00p.m. and 2.00p.m. on schooldays;
- (d) taxi-cars and chauffeur driven cars shall only have access and transit therein, without parking, to transport residents to and from hotels and residences in Mdina.

**4.** (1) The Mdina Local Council may grant a permit for vehicles to enter and circulate within the city of Mdina for a specific purpose or reason under such conditions as the Mdina Local Council may deem proper to impose.

Mdina Local Council may grant permit for temporary access.

(2) The application for the permit referred to in subregulation (1) hereof shall be in writing on the appropriate form appearing in the Schedule to this order, and such application shall be processed by the Mdina Local Council following the payment to the Mdina Local Council of an administration fee of LM 1 for each application.

Form of application.

(3) The said permit shall be in writing and signed by the Mayor and the Executive Secretary of the Mdina Local Council, and shall be displayed within the vehicle in such a manner that it may be seen and read from outside the vehicle at all times that the vehicle is within Mdina.

Permit to be signed by Mayor and Executive Secretary.

(4) The said permit shall be issued for a period which does not exceed twelve months from the date of issue, and it shall be neither transferable to any other person or to any other vehicle.

Permit not to exceed twelve months and is not transferable.

**5.** The Mdina (Restriction of Access and Transit of Vehicles) Regulations, 1988 are hereby repealed.
